

CONTRACT

This Contract is entered into on the day written below by and between the Tax Service and the individual (the "Participant") identified hereafter:

The purpose of this Contract is to engage the Tax Service to provide tax services for the Participant in the United States ("U.S."). Accordingly, the Tax Service and the Participant agree that Tax Service will perform tax services on behalf of the individual for a fee.

1. Participant's rights and obligations

- a. Participant agrees to sign a general power of attorney for tax, banking and financial matters.
b. Participant agrees to timely provide requested information and documents according to instructions.
c. Participant acknowledges the importance of accuracy and completeness of all documents submitted.
d. Participant agrees to send the Tax Service all documents and notices from U.S. (federal, state and local) authorities.
e. Participant agrees to have the Tax Service be the exclusive provider of their tax services.
f. Participant is entitled to withdraw from this Contract at no cost to the Participant as long as a tax return has not been filed. Such notice of withdrawal can be made by telephone call, e-mail, or in writing to the Tax Service.

2. The Tax Service's rights and obligations

- a. The Tax Service agrees to process all required tax documents for the Participant and submit them to the respective authorities in the U.S. in a timely manner and in compliance with all U.S. laws.
b. The Tax Service agrees to use its authority under the general power of attorney only for the preparation, signing and filing of tax returns and for receiving and negotiating (endorsing) tax refund checks.
c. The Tax Service agrees to provide a summary statement of charges and payments, at the time of any final distribution to the Participant. Tax Service agrees to fax or email this signed Contract to the Participant at any time upon written request.
d. The Tax Service shall not be held responsible for delays by U.S. authorities.

3. Consideration

- a. Payment is based on the total amount of federal, state and local income taxes withheld by the Participant's employer(s) from their compensation while in the U.S. Participant agrees to pay the Tax Service a fee of 8% of the amount withheld, but with a minimum of \$35 and a maximum of \$75 (U.S. dollars).
b. Payment will be deducted from the total of all federal, state and local refunds paid (if any) by U.S. authorities. If the Participant's total refund amount received from U.S. authorities is not equal to or greater than the minimum fee of \$35, then the Tax Service will require that the Participant remit the difference between the \$35 minimum fee and the Participant's total refund amount paid (if any) by U.S. authorities.
c. Any fees associated with direct deposit, checks in local currency, or western union will be paid for separately by the Participant and deducted from final distribution.
d. Any follow-up tax or audit participation by the Tax Service, or anyone else, is not contemplated by this agreement. This would be an additional matter with an additional fee to be negotiated at a later time.
